### **PURPOSE**

Maintenance of Certification in Anesthesia Part IV Requirement: Simulation Education Course

The ABA's Maintenance of Certification in Anesthesiology (MOCA) program consists of four parts. Part IV, also known as Practice Performance Assessment and Improvement (PPAI), requires MOCA candidates to complete both a case evaluation and a simulation course once during their ten-year MOCA cycle.

The Penn State Hershey Clinical Simulation Center is an ASA-accredited Simulation Program offering ABA endorsed courses eligible for MOCA credit. Participants must be Board-Certified or Board-Eligible Anesthesiologists, regardless of whether MOCA credit is sought. Anesthesiologists who achieved ABA Board Certification in 2004 or later are required to participate in an appropriate Simulation Education Course at an endorsed Simulation Center. ### **PROGRAM OBJECTIVES**

Upon completion, participants should be able to:

- Demonstrate appropriate recognition and medical response to hemodynamic variability in a simulated case
- Demonstrate appropriate recognition and medical response to a difficult airway situation
- Demonstrate and practice teamwork and communication skills in the context of anesthesia practice
